# Requirement from OSO Manual -

#### "Annual Financial Oversight

The persons delegated this important task should conduct the following basic financial oversight tasks.

- 1. Compare the actual expenses and revenues for the year to the budget established at the beginning of the year.
- 2. Review a sufficient number of the disbursement and revenue transactions to determine accounts were properly used and entries to the ledgers were correct.
- 3. Review receipts and other support documents to ensure disbursements were proper.
- 4. Conduct an analysis of the expenditures to verify fairness and equality exist in the support of all teams falling under the mission of the OSO.
- 5. Attain from the treasurer a compilation of any unpaid bills, uncollected revenue, and inventory items unsold to report to the membership the complete financial condition of the organization."

The auditors must be unbiased and impartial regarding the material of which is the subject of their audit. g. Transportation – Whelan - For transportation, everything is going well, especially with the change in the podiums, we can now take everything in the truck without needing to pull the trailer. We have been making repairs to our "new big podium" and have a fix for it moving when on hard surfaces. In the future, we will need to find a better solution for the pads on the bottom.

Big thanks to all the chaperones who have helped get the band on and off the field. The truck is running great, and we are looking at solutions to get lighting under the platform and possibly more running lights for the back of the truck as well as working lights when we are loading in the dark.

The yellow trailer is going to need some tailgate work done soon. The piano hinge is worn and cracking in some places. This will be a good project for the maintenance department at the end of our season.

The box trailer needs one of the locking arms fixed. Looking at it we feel it would be best if we see if the maintenance department will not just buy a new locking arm and we can replace it.
